Education:

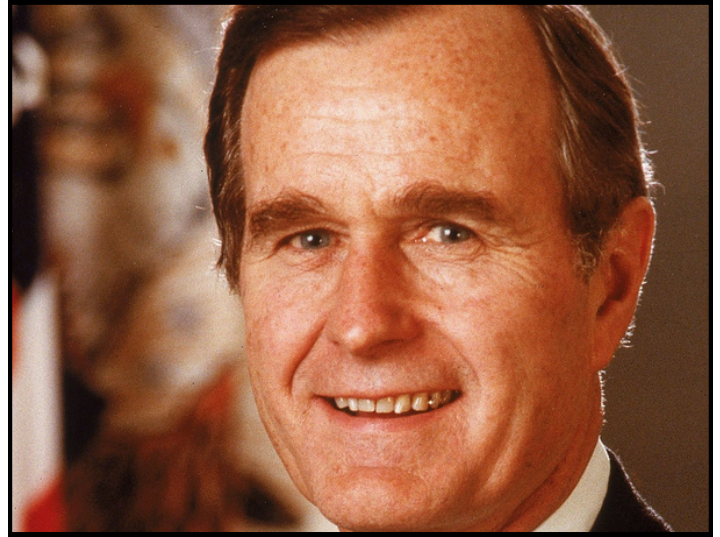
- B.A. in Economics: Yale University [22].
